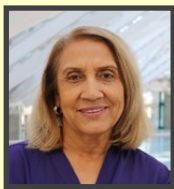


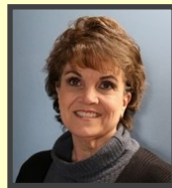

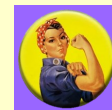

Your Right to Representation in Investigatory Meetings (Weingarten Rights):

If you get called into a meeting to be asked questions as part of an investigation, do not go in alone! Ask for a union steward or union representative. If you are denied representation, you should still go to the meeting but you have a *legal right* to refuse to answer questions that could lead to discipline.
